The APICS Binghamton Student Chapter has had a productive and momentous beginning to the Fall 2017 semester. Beginning with the goal to reestablish APICS as one of the premier School of Management (SOM) organizations on campus, the student chapter has also begun to establish itself and make efforts to grow within the Watson School of Engineering. Involvement on campus early on in the semester was the first step toward achieving this goal, with participation in several BU organization fairs and the planning of General Interest Meetings.

Following the on-campus promotion of the student chapter, several highly successful events were held in the month of September. The first of these events was a recruiting and information session with EY that was hosted by APICS along with several other SOM organizations and attracted over 100 students! This was followed by a LinkedIn event planned and conducted with the help of the Fleishman Center, SOM Career Services, Watson Career & Alumni Connections, and Management Consulting Group which assisted in the creation and development of LinkedIn profiles for BU students. NEW CPIM Certification Format Being

Offered – As you already know by now, CPIM has been converted from 5 exams required for certification to just 2 exams. BSCM, the first exam has changed to CPIM Part 1 format with same content but the other 4 previous exams have been combined into only one longer formatted exam. The conversion happened in August this year.

STAPICS (Southern Tier APICS) is going to offer a class in Part 1 of the new format starting in November 2017. The exact location has not been determined other than it will be in Broome County.

(Southern Tier APICS Update from Don Sheldon, Director of Education continued) – The cost is \$1000 per student which includes all materials and class time. It does not include the exam registration which you will have to do when you are ready to take the exam.
